Note: Actual/Assessed Valuation is multiplied by a Rollback Percentage to get to the Taxable Valuation to calculate Property Taxes. Residential and commercial properties have the same rollback percentage through \$150,000 of actual/assessed valuation.

Reasons for tax increase if proposed exceeds the current:

increase in property and liability insurance and the unrealistic value on commercial property in town. The tax asking amount is less per \$1000 than the previous year.
